## IX. CLERK'S REPORT:

#### 1. United States Census 2020 Thank You certificate for the City of Asotin

The City of Asotin received a Thank You Certificate from the United States Census 2020. The U.S. Census Bureau recognizes the City of Asotin as an invaluable member of the 2020 Census Community Partnership and Engagement Program. We appreciate the efforts you made in making the Partnership Program a success and helping achieve a successful 2020 Census. Dr. Steven D. Dillingham, Director U.S. Census Bureau. Mayor Paris stated Asotin County met their goal of reaching persons and reporting at 80% for the Census.

## 2. Latah Sanitation 2020 Annual Certificate

The City of Asotin received the 2020 Annual Certification from Latah Sanitation. From January 1,2020 through December 31,2020, Clearwater Composting received and processed approximately 147.04 tons of biosolids from the City of Asotin. When processed, this tonnage yields approximately 535.22 cubic yards of Class A Compost. These biosolids were co-mingled with other producers and the total tonnage of co-mingled Class A Compost is 18,591.44 cubic yards. The Class A Compost has been processed in accordance with the 503 regulations and has been dispersed. There were no odor complaints this year. Clerk/Treasurer, Tiffany Rogers stated the grit removal is taken to the Asotin County Landfill once a week.

#### **DEPARTMENTS:**

## a. POLICE DEPARTMENT:

Police Chief, Monte Renzelman stated there are additional matters that occur within the City of Asotin that most people are not aware of that keep him busy. Already in January he is investigating a rape, an assault with a fire arm, and had a sex offense reported last week. He has been working on abandoned vehicles and boats. Asotin is a 24-hour 7 day a week department, no matter what crime is called in, they will handle the investigation. They may call in mutual aid but ASPD will be the lead agency of all those types of cases that are within the Asotin City Limits. He is finishing up the NIBERS, which is the end of the year reporting for the state and federal government, and mandated tasks Police departments are required to perform, which has been time consuming.

Police Chief, Monte Renzelman stated the city has a city-wide notification system called Regroup Mass Notification acquired through the CARES funding. The city is in the beginning stages of instructing the staff and uploading the information. There will be information sent to allow citizens to sign up for the notifications if they choose to receive them. The types of notifications will be of any notifications that may need to inform the citizens of, such as street closures, fires, floods and/or stormwater street sweeping, or heavy police activity in an area that needs people to stay clear of, etc. The citizens will be able to choose how they want to receive the notifications, such as via phone, e-mail or text. Persons who work within the city limits are also eligible to receive the notifications, plus families of students who attend the Asotin-Anatone School District can sign up as well. Employees of the Asotin County Court House and Annex and all city businesses can sign up too. You do not have to be a citizen of the City of Asotin to sign up. The program can reach a block of citizens, city wide and/or just the affected area.
