The following information is required to be submitted with your Roofing Permit Application.

Your Roofing Permit Application cannot be accepted or processed unless all of the information is provided.

Required Information:

1. Fill in items **1 thru 9** on the application form that apply.
2. Installers Name and License #.
3. In Section 7 describe work please list all Materials (sizes and types) you will be using include sq. foot of roof area if more room is need please put on back of application.

Permits are processed in the order they are received. Permits are normally issued within two weeks from date submitted. Please be as accurate and thorough as possible.

Inspections Required for Roofing

INSTALLATION:

1. Please call for inspection when old roof is removed.
2. If new sheeting is required please call for inspection before covering.
3. If no tear off is required no more than 2 old layers allowed.

FINAL:

When roofing is complete.

To request an inspection please call Bob Portlock at 208-791-4663. 24 hours' notice is required. Please give name, location, type of inspection and permit number. Inspector Hours are 8:00am to 2:00pm.

Permit must be on site for Inspection.

**Asotin County
Optional Sales Tax
Effective April 1, 2024**

Effective April 1, 2024, sales and use tax within Asotin County will increase two-tenths of one percent (.002). The rate change reflects an increase for the optional sales tax.

Businesses must collect the appropriate new rate of sales tax for retail sales and services provided within Asotin County. Persons or businesses within Asotin County will be subject to the new rate of use tax on items purchased for their personal or business use if sales tax has not been paid.

The new rate of sales tax is:
